

## Reproduction Fees

Reproduction fees are additional to the cost of processing and supply, and where applicable, fees which may be payable to the copyright owner. Fees for the reproduction of material are charged by the Museum as proprietor of the material – they are not copyright fees. Reproduction fees are used for the preservation of the Museum collections.

- Fees quoted are per image for New Zealand rights only.
- Fees quoted include GST.
- Fees apply only to the one-time use as designated in the reproduction agreement. Any further use will require the permission of the Museum, a new application, and may incur an additional fee.
- Fees may be negotiable when a large number of images are being used.
- Discounts may apply for local history and not-for-profit organisations, this will be discussed at the time of application.
- Fees are reviewed on a regular basis and may change from time to time, without notice.
- Fees may be paid by cash, cheque, or eftpos, and are required prior to the order being processed, unless other arrangements have been made.
- An additional service charge of \$100 per hour applies to customised work and digital file preparation, where required.

## Fee Scale for Reproduction

Reproduction fees are charged in addition to the costs of processing and supply, and fees for the copyright of the original. Note – the processing and supply charge reflects the actual cost to the Museum, and discounts cannot be given. Fees are not charged for the use inside a book, serial or newspaper.

### Fee Scale for reproduction and display (New Zealand rights)

Book	no charge
Book, periodical and album covers, annual reports	\$250
Greeting cards, postcards, calendars	\$100
Brochures, business cards, letterhead	\$100
Advertising and Commercial display *	\$300
Decoration in a public space/office	no charge
Web site (non-commercial)	\$20
Television and commercial film	\$40 (in addition to a filming fee of \$100 per hour)

Reproduction art prints, published separately or in portfolios; facsimiles of complete volumes of books, pamphlets, periodicals, manuscripts, etc; or transcribed texts of manuscripts 5% of the RRP of the entire print run, prepaid.

Other uses will be discussed at the time of the application.

Prices are per image unless otherwise stated, in New Zealand dollars and include 15%GST.

\*Commercial Display includes: billboards, interpretation panels and all advertising posters and displays, web advertising.

# REPRODUCING MATERIAL FROM THE NELSON PROVINCIAL MUSEUM COLLECTIONS



The Nelson Provincial Museum (referred to as Museum from this point) welcomes the reproduction of items from its collections and copies may be purchased from the Museum. In order to protect the integrity of our collections and to ensure their appropriate usage we ask that certain conditions be observed. Members of the public are not permitted to photograph, scan or film Museum collection objects or to reproduce Museum material from published sources or web display. The Museum holds objects in its collection acquired by bequest, donation or loan. Some of the material is still in copyright and some has been accepted under special conditions.

The Museum has a responsibility to ensure that the material in its care is used in a way consistent with the undertakings made at the time of acquisition or deposit, recognising cultural and personal sensitivities and upholding the integrity of the original item. While every effort is made to ensure that the Museum's collections are free of legal restrictions and available for public use, the user has the responsibility for clearing copyright, and for meeting any other requirements placed on the object, by the owner/donor/creator of the original.

### Conditions of Reproduction or Display

Permission, in writing, must be obtained from the Museum prior to the reproduction of any images of its collections, exhibitions or interior spaces. Applications should be made on the Museum's *Photographic Order / Application to Reproduce Images* form and must describe the intended purpose. Fees may apply for the use of images for commercial ventures. The Museum reserves the right to refuse any application to reproduce material, and/or to stipulate any conditions as to its use. The Museum does not grant wider permissions such as exclusive rights, perpetual rights or world rights. For the purpose of future reference, at least one copy of the published material containing Museum images should be provided to the Museum free of charge.

### Restrictions

In order to maintain the integrity of the Museum's images, no manipulation of the image is allowed, for example, outlining, overlapping, distortion (altering the proportions of the image, duotone washes, or other colouring). Digital images are supplied uncropped. Customers must seek permission from the Museum to alter an image, and if granted, must specify this in the acknowledgement. Similarly, filmmakers need permission to zoom in and out of an image. Text, such as titles or underlying text, should not intrude on the image. The Museum does not supply negatives. The Museum can provide reproductions of most items from the collections, subject to the type of request being made, the condition of the object, or restrictions placed on the object at the time of deposit.

### Authorisation

Permission to reproduce covers only the specified occasion and purpose described on the photographic order form. Any additional use requires a new application and may incur an additional fee. Permission is required for the recording of items from the collections on videotape, film, or any other information storage media. Requests to use material with Maori content or connection.

may be subject to approval by Iwi. All reproductions must be approved by the Manager, Collection Services, or their delegate. The Museum reserves the right to refuse to reproduce any material for research purposes or for reproduction in another format. ### Format

In order to be assured that the quality of the published image is satisfactory, the Museum requires any reproductions from the collections to use the digital copy supplied by the Museum. For published images the Museum can provide a range of formats.

### Digital reproductions from the Museum collections will be supplied in the following formats:

- TIFF format (300dpi) on CD or DVD
- Monochrome (B&W) originals digitised @ 8 bit grayscale
- Colour originals digitised @ 24bit RGB (Adobe 98)
- Jpeg format (300 dpi) compressed for email delivery

### Reference copies

The Museum may supply, for the purpose of research or private study, one copy only of material from published works. These reference copies are not to be copied, or reproduced in any other manner.

### Copyright

Reproduction and Copyright are not the same. The Museum may or may not hold copyright to an item in its collection. It is the client's responsibility to seek written permission of the copyright holder and to meet any conditions they stipulate. The Museum will assist with locating copyright holders as time allows. Whether the Museum holds copyright or not, or where copyright no longer exists, the Museum will still require a reproduction agreement to be completed, and the appropriate fees paid. Copyright exists in published and unpublished literary works, musical and artistic (graphic, photographic, sculptural, architectural and craft) work for 50 years after the death of its creator. Where access to material not covered by copyright, and copying of that material, is restricted, responsibility for obtaining consent to copy the material, lies with the applicant. Museum staff will assist with this as much as they are able. For further information see our fact sheet *Copying Material From The Nelson Provincial Museum Collections*.

### Acknowledgement

Acknowledgement to the Museum, and the correct citation, including attributing the work to the original author/artist/photographer/maker, and title, where known, must accompany the reproduction of Museum material. The caption supplied with each image includes citation details. The acknowledgement, including the reference number, should appear adjacent to the reproduction. Where this is not possible acknowledgement must appear in a manner that allows clear identification of the material. Acknowledgement must be given for quotations and references to the Museum's textual material from manuscripts and archives. Where a Museum image is used on a web site, or in digital media, the following text must be displayed: *Permission of the Nelson Provincial Museum, Nelson, New Zealand, must be obtained before any re-use of this image.*
